



Investment Objective

The Leverage Shares -1x Short Baidu ETP Securities seeks to track the iSTOXX Inverse Leveraged -1x BIDU Index, which is designed to provide -1x the daily return of Baidu, Inc. ADR stock, adjusted to reflect the fees and inherent costs and revenues of shorting. It holds the short positions in the underlying Baidu, Inc. ADR stock and resulting cash balances.

For example, if Baidu, Inc. ADR rises by 1% over a day, then the ETP will fall by 1%, excluding fees. However, if Baidu, Inc. ADR falls by 1% over a day, then the ETP will rise by 1%, excluding fees.

Key Features

- Opportunity to magnify returns in one simple trade.
- Liquid. Trades like an equity on exchange, with multiple market makers (MMs).
- You cannot lose more than the amount invested, and an intraday rebalance mechanism is designed to cushion the largest intra-day falls.

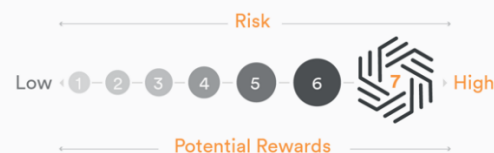
