### **Notice to ETP Securityholders of the Series of ETP Securities listed in the Schedule 1 hereto (the “Relevant Series”)**

Capitalised terms used, but not defined, in this notice shall have the meaning given thereto in the Master Definitions Schedule in relation to the Leverage Shares plc collateralised exchange traded securities programme (the “**Programme**”).

Leverage Shares plc (the “**Issuer**”) refers to the notice issued on 19 September 2023 in relation to the change of Margin Loan Provider from Interactive Brokers Ireland Limited to Interactive Brokers LLC (the “**Migration**”). The Margin Accounts at Interactive Brokers LLC are governed by the terms of a New York law governed client agreement dated 19 September 2023 (the “**IB Margin Account Agreement**”).

The Issuer hereby gives notice of the following:

- (1) With effect from 18 October 2023, the Conditions governing the Relevant Series and the Master Definitions Schedule applicable to each Relevant Series will be amended and restated (the “**Amended and Restated Conditions**” and the “**Amended and Restated Master Definitions Schedule**”) to reflect the Migration. pursuant to the terms of a deed of amendment and restatement entered into between the Issuer and the Trustee (the “**Deed of Amendment and Restatement**”).
- (2) On 18 October 2023 the Issuer and the Trustee have entered into a New York law governed security agreement pursuant to which the Issuer has granted security interests in favour of the Trustee for its benefit and for the benefit of the Secured Creditors over the Issuer’s rights, title, interest and benefit under the IB Margin Account Agreement and the Issuer’s rights as against Interactive Brokers LLC under the IB Margin Account Agreement to the extent that they relate to the Relevant Series (the “**IB Security Agreement**”).

The amendments outlined at paragraphs (1) and (2) above are referred to herein as the “**Modifications**”.

The Issuer is permitted to make the Modifications without the consent of the Trustee or the ETP Securityholders of the Relevant Series pursuant to Condition 14.2(B). The Trustee has entered into the Deed of Amendment and Restatement and IB Security Agreement for the purpose of giving effect to the Modifications in accordance with Condition 14.2(B).

The Amended and Restated Conditions are included as “Terms and Conditions Version 7” in the Issuer’s Base Prospectus. The Base Prospectus, the Amended and Restated Master Definitions Schedule and the IB Security Agreement are available on the Issuer’s website at [www.leverageshares.com](http://www.leverageshares.com).
