The Leverage Shares 2X Long BBAI Daily ETF (the “Fund”) seeks daily leveraged investment results and is very different from most other exchange-traded funds.

As a result, the Fund may be riskier than alternatives that do not use leverage because the Fund’s objective is to magnify (200%) the daily performance of the publicly traded common stock of Bbai, Inc. (NASDAQ: BBAI) (“BBAI” or “Bbai” or “Underlying Security”).

For periods longer than a single day, the Fund will lose money if BBAI's performance is flat, and it is possible that the Fund will lose money even if BBAI's performance increases over a period longer than a single day. An investor could lose the full principal value of his/her investment within a single day if the price of BBAI falls by more than 50% in one trading day.

The Fund's daily returns may be affected by many factors but will depend on the performance and volatility of the Underlying Stock.
