The Leverage Shares 2x Long CRWV Daily ETF (the "Fund") seeks daily leveraged investment results and is very different from most other exchange-traded funds.

As a result, the Fund may be riskier than alternatives that do not use leverage because the Fund's objective is to magnify (200%) the daily performance of the publicly traded common stock of CoreWeave, Inc. (Nasdaq: CRWV) (CRWV or Underlying Security).

The Fund will lose money if the underlying security performance is flat over time, and as a result of daily rebalancing, the underlying security's volatility and the effects of compounding, it is even possible that the Fund will lose money over time while the underlying security's performance increases over a period longer than a single day.

For periods longer than a single day, the Fund will lose money if CRWV's performance is flat, and it is possible that the Fund will lose money even if CRWV's performance increases over a period longer than a single day. An investor could lose the full principal value of his/her investment within a single day if the price of CRWV falls by more than 50% in one trading day.

Leverage Risk: The Fund obtains investment exposure in excess of its net assets by utilizing leverage and may lose more money in market conditions that are adverse to its investment objective than a fund that does not utilize leverage.

Derivatives Risk: Derivatives are financial instruments that derive value from the underlying reference asset or assets, such as stocks, bonds, or funds (including ETFs), interest rates or indexes.
