## Fund Summary

The Leverage Shares 2X Long Coinbase Daily ETF (the “Fund”) seeks daily leveraged investment results and is very different from most other exchange-traded funds. As a result, the Fund may be riskier than alternatives that do not use leverage because the Fund’s objective is to magnify (200%) the daily performance of the publicly traded common stock of Coinbase (NASDAQ: COIN) (“Coinbase” or “Coinbase Global Inc.” or “Underlying Security”).

**Leverage Risk:** The Fund obtains investment exposure in excess of its net assets by utilizing leverage and may lose more money in market conditions that are adverse to its investment objective than a fund that does not utilize leverage.
